# 17.15 Minutes of the Meeting held on 3 January 2017

## 17.16 Public Participation

Residents provided information on a planning application for Higher Healey Farm, Higher House Lane. The site address was believed to be within the Chorley East ward boundary and, as such, had not appeared on the Parish Council's planning lists.

A representative from Inspire (Chorley Youth Zone) provided information on the construction progress and details of operations once the Youth Zone is opened. Councillors questioned the availability of transport for young people to access the facility. This will be looked into.

An invitation to participate in a chain of beacons commemorating the end of WW1 on the 11 November 2018 was considered. Enquiries are to be made to see whether Wheelton Parish Council is taking part and further information is to be requested from the organisers.

#### 17.22 Lancashire Best Kept Village Competition

St Barnabas Church, The Top Lock, the War Memorial and White Coppice Cricket Club were nominated for the Certificate of Merit Section entries. There was a suggestion to enter the War Memorial at White Coppice however it was believed only one could be nominated. Wheelton Parish Council is to be asked whether the shared memorial could be entered by them.

### 17.23 Consultation

Councillors considered a consultation on the Draft Central Lancashire Employment Skills Supplementary Planning Document. Councillors had no comments.

#### 17.24 Reports from Outside Bodies

Eastern Parishes Neighbourhood Area meeting – the Goit footpath is to be repaired. The issues around the footpath by the picnic area in White Coppice is still ongoing.
