Councillors will also review the requirements detailed on the Internal Auditor Testing document (enclosed), Again, Councillors are requested to satisfy themselves that the scope of the document is adequate and are invited to suggest amendments as appropriate.

Councillors will discuss the appointment of an Internal Auditor for the year ending 31 March 2024 (the current Internal Auditor, Mrs Amanda Partington, has confirmed her willingness to carry out the audit). A fee for the internal audit for the year ended 31 March 2024 will be confirmed. A fee of £80 was agreed in 2019.

Best practice guidance for the appointment of an internal auditor and internal audit can be found in Sections 4.1 - 4.18 (pages 24 - 26) and 4.20 - 4.21 of the Joint Panel on Accountability and Governance Practitioners' Guide.

8. Public Access Defibrillator

A suggestion for provision of a defibrillator and a weatherproof cabinet at White Coppice Cricket Club will be considered. From the information provided, it is not clear whether the Cricket Club will allow a defibrillator to be located on the site or allow connection to its power supply. Further details are awaited. Should this be clarified in time for the meeting, Councillors may wish to consider gifting the defibrillator to the Cricket Club

9. Memorial Seat

An offer from a resident to place a seat in the vicinity of the notice board on Blackburn Road will be considered.

A licence or permission will be required from Lancashire County Council. Councillors will need to consider potential ongoing maintenance and insurance costs.

10. Precept

Councillors will be invited to provide suggestions for items for inclusion in the Precept for 2024-2025. This is to allow estimated costings to be obtained in time for the setting of the Precept at the January meeting. One item for consideration is the current funding of the hosting fee and domain name for the village website heapeyandwheelton.org at a cost of £90.00 (+VAT) per annum. The village website contains useful information and links and this cost was originally shared with Wheelton Parish Council until Wheelton PC obtained its own dedicated site. Councillors will consider whether this funding should be included.
